

# GUARANTEE



MANN+HUMMEL FT Poland Spółka z ograniczoną odpowiedzialnością Sp. k. (manufacturer of filters under the WIX FILTERS® brand name, member of MANN+HUMMEL GmbH, hereinafter referred to as MANN+HUMMEL FT Poland), hereby guarantees that each filter manufactured and launched onto the market under the WIX FILTERS® brand name is free from any material and manufacturing defects, and will retain all its parameters and properties for its entire lifetime if used in accordance with its purpose as specified by the manufacturers of engines, motor vehicles and devices in which the filter is installed.

The guarantee does not cover defects resulting from the improper installation and/or use of the filter in breach of the manufacturer's recommendations, nor does it cover damage or defects due to the installation of the filter in a vehicle used for car racing, or in an engine modified by a non-manufacturer. Should any defect of a WIX FILTERS® filter be reported during its installation, or during its lifetime as specified by the manufacturer of the engine, motor vehicle or any other device using the filter, MANN+HUMMEL FT Poland guarantees that it will replace the defective filter with a product free of any such defect. Furthermore, MANN+HUMMEL FT Poland hereby undertakes to reimburse any justified expenditures, such as labour costs and the costs of the replacement of the defective parts incurred by the client as a result of the malfunction of the WIX FILTERS® filter.

To exercise the rights under this guarantee, the client shall be required to file a claim with a WIX FILTERS® Authorised Dealer forthwith, no later than within 30 days of the disclosure of the defect. Furthermore, the client shall be obliged to deliver the defective product to the Quality Department of MANN+HUMMEL FT Poland in order to facilitate the carrying out of the appropriate inspection and analyses. If necessary, the client shall also be required to deliver, at the request of a representative of MANN+HUMMEL FT Poland, the engine, vehicle or device claimed to have been impaired, for the assessment of the damage, and the finding of the reasons behind it.

MANN+HUMMEL FT Poland shall not be held liable for any loss of potential profits, revenue, or losses for reasons other than specified herein. The liability of MANN+HUMMEL FT Poland shall be limited to the amount of the actual value of the damaged parts of the engine, vehicle or device, and the actual value of the costs of the labour necessary to restore the damaged parts to their original condition. The purchase and installation of filters under the WIX FILTERS® brand name assumes the reading and accepting of the terms and conditions of this guarantee.
